Installment Payment Schedule: (Check or Credit Card)

Cancellation Policy: All cancellations must be emailed to: ski@bcskiclub.org

We are subject to penalties for late payments and cancellations and need to assess these as well:

- * \$50, if you cancel 100 days prior to departure, plus any supplier penalties
- * \$100 if you cancel 99-50 days prior to departure, plus any supplier penalties
- * \$200 if you cancel 50-35 days prior to departure, plus any supplier penalties
- * No refund if you cancel within 35 days prior to departure
