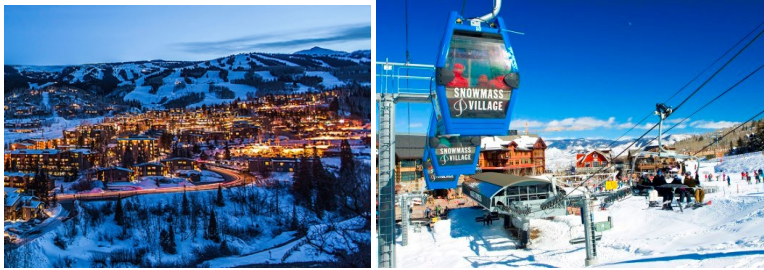

- Round Trip Air - LAX to ASE (Aspen) on United (only 15 minutes from the resort!!)
- Ground transportation to and from Aspen Airport and Condos

Saturday, February 2nd, 2019: UA5209 Depart ASE 12:15PM, Arrive LAX 1:32PM (new time) \*

Note: We are flying on United Airlines and are subject to changes made by United to prices, schedules, bag fees, surcharges, etc. Carryon items are limited to one bag plus one smaller, personal type item. See [www.united.com](http://www.united.com) for current baggage charges and policies.

**PAYMENT SCHEDULE (Regular pricing and online/paypal):**

\$379 - Due July 11, 2018 to hold your spot!

\$450 - Due by September 1, 2018

\$450 - Due by October 1, 2018

\$400 - Due by November 1, 2018 - must be paid in full or you risk being assessed a late fee and/or you may lose your spot

**CANCELLATION POLICY:**

- All cancellations must be in writing and emailed to: [ski@bcskiclub.org](mailto:ski@bcskiclub.org)
  - We have to adhere to our Ski.com contract and cancellation policy:
    - *August 1st to September 20th, \$100 per person plus any supplier penalties\**
    - *September 21st to October 20th, \$300.00 per person plus any supplier penalties\**
    - *October 21st to December 9th, \$500 per person plus any supplier penalties\**
    - *No refunds after December 10th\**
- \* BCSC will work with you and ski.com to minimize penalties. If a trip replacement is found, transfer fees will apply and may be less costly than the cancellation penalty.*
