\$500 - Due by November 1st, 2019 - must be paid in full or you risk being assessed a late fee and/or you may lose your spot

#### **CANCELLATION POLICY:**

- All cancellations must be in writing and emailed to: ski@bcskiclub.org
- We have to adhere to our Ski.com contract and cancellation policy which is:
  - September 4th to October 15th, \$150 per person plus any supplier penalties\*
  - October 16th to November 15th, \$300 per person plus any supplier penalties\*
  - November 21st to December 9th, \$500 per person plus any supplier penalties\*
  - No refunds after December 10th\*
  - \* BCSC will work with you and ski.com to minimize penalties. If a replacement is found, transfer fees will apply and may be less than the cancellation penalty.

**TRAVEL INSURANCE:** It is strongly recommended that you purchase trip insurance

- Trip Insurance is \$90 for Steamboat package (no lift)
- Trip Insurance is \$56 for Steamboat package without air, ground, and baggage
- Two payment options available:
  - Separate check made out to Ski.com payable with first payment
  - o Online via a link provided from Ski.com link will be sent after sign-up form received
- Trip insurance cannot be purchased after November 1st, 2019

**PRE-EXISTING CONDITION** means a Sickness or Injury during the 60-day period immediately prior to your effective date for which you or your Traveling Companion: (1) received, or received a recommendation for, a diagnostic test, examination, or medical treatment; or (2) took or received a prescription for drugs or medicine. Item 2 of this definition does not apply to a condition which is treated or controlled solely through the taking of prescription drugs or medicine and remains treated or controlled without any adjustment or change in the required prescription throughout the 60-day period before coverage is effective under this Policy.

The following **exclusion** applies to the Medical and Dental, Trip Cancellation, Trip Interruption, and Travel Delay coverages:

We will not pay for loss or expense caused by or incurred resulting from a Pre-Existing Condition, as defined in the Definitions section, including death that results therefrom.

This Exclusion does not apply provided you meet the following requirements:

- a. coverage is purchased prior to or within 24 hours of your final Trip Payment; and
- b. you are medically able to travel at the time the coverage is purchased.

NOTE: BCSC is not responsible for any trip reimbursements if you choose not to purchase trip insurance.
